This Small Grant Agreement between the parties relates to the implementation of the Project **Ī Sewing course for RAE CommunityĪ** supported by the small grant from the Slovak ODA under the Contract No. **SAMRS/SG/2013/16SRB**.

1. The Active Women of Gjakova agrees to implement the project as described in its Small Grant Application Form as the Final Beneficiary.
2. The aim of the project is to train women and girls of RAE community in sewing in order for them to gain a set of skills that will help their potential employment in the future.
3. The project is to be implemented by the Final Beneficiary within six months from the signing this agreement.
4. The total amount of the financial contribution from the Slovak Agency for International Development Cooperation to the Final Beneficiary will not exceed **EUR 2 150** (in words two thousand one hundred fifty).
5. With this support the Final Beneficiary will pay for 4 instructors, fuel, 1 sewing machine, materials for sewing, 25 certificates, material for course (notebooks, pencils, erasers, rulers, measuring tapes, fabric scissors).

the Slovak Agency for International Development Cooperation will be available and can be spend only after signing this agreement.

7. The Final Beneficiary shall provide the Liaison Office of Slovakia in Pristina with the Project Completion Report including the Financial Report within **45 days** upon the completion of the project. Both documents shall be submitted in English language. The Financial Report shall contain the complete accounting documentation, i.e. order of services, invoices from service providers and payments made by the Final Beneficiary. The sample forms of the Completion Report and the Financial Report are attached to this Small Grant Agreement.
8. The Final Beneficiary will permit the monitors and evaluators of the Slovak ODA to access the documentation related to the project implementation and to provide them with assistance in reviewing the project progress and impact.
9. The Final Beneficiary is obliged to use the Slovak Aid logo on all information outputs relating to the implementation of the project.
10. The Final Beneficiary is obliged to respect the implementation time schedule and budget lines and to inform the Slovak Agency for International Development Cooperation on all circumstances which can cause any significant deviation and/or jeopardize the project objectives and outputs.
11. Should the Final Beneficiary use the financial contribution contrary to the agreed project description, the Liaison Office of Slovakia in Pristina may decide to stop the project financing. Consequently the Slovak Agency for International Development Cooperation may terminate this Small Agreement and demand the return of allocated money.
12. The Final Beneficiary is obliged to return the allocated money within 15 days from the date this Small Grant Agreement is terminated. The allocated money should be returned to the account of the Liaison Office of Slovakia in Pristina.
13. If the Final Beneficiary does not return the allocated money within the above time period the Slovak Agency for International Development Cooperation may charge it with the late payment fees.
